INSTRUCTIONS FOR AUTHORS

The mission of *Studia Universitatis Babes-Bolyai* (*Studia UBB*), the official publication of the Babeş-Bolyai University, is to publish new scientific contributions in all the fields of sciences.

Manuscripts cannot have been previously published or be currently submitted elsewhere for publication while in review for Studia Universitatis Babes-Bolyai, although manuscripts may have been deposited on a preprint server. Manuscripts that are derived from papers presented at conferences can be submitted unless they have been published as part of the conference proceedings in a peer-reviewed journal. Authors are required to ensure that no material submitted as part of a manuscript infringes existing copyrights, or the rights of a third party.

Manuscripts must be submitted by one of the authors of the manuscript, and should not be submitted by anyone on their behalf. The submitting author takes responsibility for the article during submission and peer review. Submission of a manuscript to Studia Universitatis Babes-Bolyai implies that all authors have read and agreed to its content.

Peer-Review Process

Studia UBB has adopted the **double-blind peer review** system. The guest editor(s), together with the journal's editor(s) in charge of the special-themed issue, first select the submissions according to their relevance to the topic. Submissions passing the initial editorial screening enter the double-blind peer review process. As a rule, this involves the anonymous evaluation of each submission by 2 external referees (from outside both Babeş-Bolyai University and the institution to which the author of the article is affiliated) identified as specialists in the respective academic area.

The review of the submissions is done:

- through elaborate comments on the text, which allow the reviewers to freely and constructively express their suggestions, criticisms, and appreciations.
- by filling the peer-review form that evaluates the following aspects:
 - the clarity of the title and its appropriateness to the content of the manuscript,
 - the way in which the abstract captures the content of the manuscript,
 - whether the introductory section outlines the relevance of the article for the given field, offers a good overview of previous studies on the same topic, and presents a clearly formulated thesis,
 - whether the paper has a solid and well-informed theoretical background, relevant for the analysis/ argumentation,
 - the originality of the paper and the significance of its contribution to the field.
 - how the concluding section summarizes the results and the consequences/implications,

- the quality and relevance of references,
- appropriate citation and referencing,
- stylistic and grammatical accuracy.

The reviewer's decision materializes in one of the three possible recommendations, namely: acceptance in the initial form, conditional acceptance (minor/ moderate/ major changes in form, style and/or content), or rejection. In the event of significant discrepancy between the recommendations of the two reviewers, a third specialist is called upon to assist in the final decision of publication or rejection.

Style Guide

Contributors must provide their names and affiliations and e-mail addresses with their papers.

Summary and keywords must be in English. Authors for whom English is not a native language must have their manuscripts reviewed by a colleague who is fluent in English before submitting their manuscripts.

The **Title** should be informative but not longer than 15 words. Please supply a short title of up to 70 characters.

Name of the author(s). Give the full author(s) name(s). Institutional affiliation, ORCID and e-mail addresses must be keyed for each author. In case of more than one author, please indicate the email of the correspondent author.

Abstract & Keywords. The abstract (not exceeding 250 words) must be written in English, outlining concisely the main findings and major conclusions of the paper. Literature citations and figure references should not appear in the abstract. Include up to 8 keywords beneath the abstract for indexing purposes.

Text. Manuscripts should be typed (single spacing) on A4 paper (21 x 29.7 cm) leaving a margin of 4.5 cm all around. Authors should use IUGS terminology and metric units. All pages should be numbered consecutively; illustrations and tables must be incorporated into the text or at the end of manuscript, with a list of illustrations or an appendix (for tables).

Book reviews should contain the name of the author and book reviewed, place of publication, publisher, year of publication, number of pages and illustrations if the case, and ISBN number. Book reviews would normally be maximum 1,000 words in length.

All references cited in the text should be given in the reference list except the case when footnotes are the preferred referencing system. The reference list should be arranged alphabetically and chronologically, with the authors always listed with their last (family) name first. Journal and book titles must be spelled out in full or abbreviated and cited in the text. Include diacritical marks (accents, umlauts etc.) in all titles and names. For books and articles with a non-English title, please translate them into English and mention in parentheses at the end of the reference the original language. (This is not necessary for Spanish, German, Italian or French titles).

Illustrations must be submitted in with a preferred resolution of 300 dpi and must be sized to the text width of 13 cm (B5 format). The numbering of the illustrations (e.g., Fig. 3) or (Pl. II, Fig. 1 or Figs. 3-5) must correspond to their order of appearance in the text.
